- Thanks to Diane for her presence on Monday and Thursday zazen, Sat. class, Brown Bag and sewing circle at the S.F. Center. Hers is a wonderful presence
- Guy is starting steps towards priest ordination with the complete support of the TC.
- Are ordinations independent of MBZC re: employment status for TC?
   Response: The relationships are between students and teachers who are independent contractors
- Does the Board decide on classes with TC? The TC is 100% responsible for determining the education offered to the community, sanctioned by the Board. The Board oversees the TC

## V McGowan House (McG)

- Diane sent email that McG is opening to in person meetings on 6/15. There is uncertainty about masks though MCG has a masking?distancing policy
- Overview of connection to McG. Kathy has been the primary contact person. Now, due
  to her health, she has stepped down. Diane has agreed to take it on to centralize MBZC
  communication with MCG. She completes any required forms
- Church in flux awaiting new Minister who will arrive in July. Diane will have an
  introductory meeting with him and a committee, Susan N. & Dina (representing MCG
  Organizing Committee) and a representative from the TC (Robert will provide name) will
  also have a welcome meeting, to be followed up with ongoing meetings
- Diane will discuss Brown Bag participation with Kathy

### VI Restarting in-person practice

- CA reopening 6/15
- Ashland Zen Center has reopened in person. Vaccinations are required. They are continuing Zoom as well
- Diane has purchased equipment necessary for Zoom meetings

- Are we in a position to restart in-person practice? Is TC ready to look at this?
- Diane reports morning zazen will remain on zoom for at least a month or two as many remote participants attend
- Tuesday nights? People are hesitant until July, then perhaps proof of vaccination, no chanting, masks. No re-opening policy has been formulated yet
- Guidelines for religious practices are needed; sufficient information not yet available
- Premature to make decision right now
- Need to workout how we continue to include people who have been zooming with us who are unable to join in person
  - 1. How can we electronically do it?
  - 2. What would it cost?
  - 3. Robert, Sara, Diane formed a committee last meeting; what are others doing including electronics
- By July option to meet in person should be ready
- Possible Tuesday in the old way and add an additional zoom night
- Considering internet issues at Cherry and McGowan, could switch back and forth with one zoom and one in person; hybrid zoom and in-person when there is no discussion
- City Center put out a statement; Diane will send link to Board
- No action items. Committee will work on a plan
